The Guest may choose to take out a deposit insurance (hereinafter referred to as the "Waiver") as an alternative to paying a full refundable security deposit.

This Addendum (hereinafter referred to as the "Waiver") governs the terms and conditions under which the Charter Company offers an optional service of reducing or cancelling the security deposit.

By paying the Waiver fee, the Guest is entitled to limited coverage for certain damages incurred during the use of the vessel, in accordance with the terms and conditions set forth in this Addendum.

The Waiver is not an insurance policy, but a contractual limitation of the Guest's liability under the terms and conditions set forth in this Addendum.

OPTIONS AND AMOUNTS

The Guest may choose one of the following options:

a) Standard Deposit

The Guest shall pay the full security deposit in accordance with the price list of the vessel. The deposit shall be returned after the vessel has been inspected, less any damages.

b) Basic deposit insurance (Basic Waiver)

a non-refundable fee is payable

the deposit is reduced to the amount defined for each vessel (e.g. €500 / €800 / €1000)

covers exclusively the damages defined in Article 3

c) Carefree package

includes Waiver

reduced deposit

additional services (e.g. outboard motor, WiFi, etc.)

simplified check-out

d) Full Relax package

there is no obligation to make a deposit

includes extended coverage

includes additional services and priority check-in

WHAT IS COVERED

Waiver covers accidental damages that occur during the normal and proper use of the vessel.

This includes:

- 1) minor accidental damage incurred during maneuvering (e.g. docking, mooring)
- 2) rope in the propeller**
- 3) selected operational damage incurred during normal use of the vessel
- 4) minor unintentional damage to the interior and exterior

COVERAGE CONDITIONS

Coverage applies only under the following conditions:

- 1) the vessel is operated responsibly and in accordance with professional rules
- 2) all terms of the charter agreement are observed
- 3) applicable maritime regulations are observed
- 4) damage is reported immediately to the Charter Company

WHAT IS NOT COVERED

The waiver does not cover the following:

A) gross negligence or irresponsible behavior

B) intentional damage

C) damage incurred through breach of contractual or legal obligations

D) damage incurred under the influence of alcohol or intoxicants

E) loss or theft of equipment (e.g. dinghy, outboard motor, inventory)

F) toilet blockage due to improper use

G) fuel-related errors

H) delay in returning the vessel

I) damage caused by ignoring weather conditions

J) damage caused by inexperience or incompetence of the skipper

K) damage not reported immediately

In all such cases, the guest bears full responsibility for the entire cost of the damage.

LIABILITY AND LIMITATION

The waiver reduces the guest's financial liability for covered damages to the amount of the security deposit.

Any damage exceeding the amount of the deposit remains at the expense of the guest.

FINAL PROVISIONS

The waiver is optional and non-refundable.

By selecting the Waiver, the guest confirms acceptance of all terms and conditions defined in this Addendum.

This Addendum forms an integral part of the Charter Agreement.
